The REA Impact: Long-term Partnership & Ongoing Success

The 61st District Court's Adult Treatment Drug Court, with REA's steadfast support, has once again secured a significant 5-year funding grant from SAMHSA. This achievement marks an impressive 16-year track record of sustained federal funding, a testament to meticulous adherence to grant requirements and timely report submissions.

REA has implemented a system to prompt follow-up for tagged cases and schedule hearings for individuals due for review. Upon completion of our latest grant, we will present a comprehensive recidivism analysis in December.

Participants in the program actively attend recovery meetings, receive counseling, and are expected to consistently yield negative results on drug tests. Upon graduation, individuals may experience reduced or dismissed charges.

Thanks to SAMHSA grants, the program has expanded, enabling the 61st District Court's Adult Treatment Drug Court to focus on those with a higher risk of continued substance abuse, criminal recidivism, and potentially life-threatening outcomes. This funding has been pivotal in enhancing outcomes and making a life-saving impact in the community.

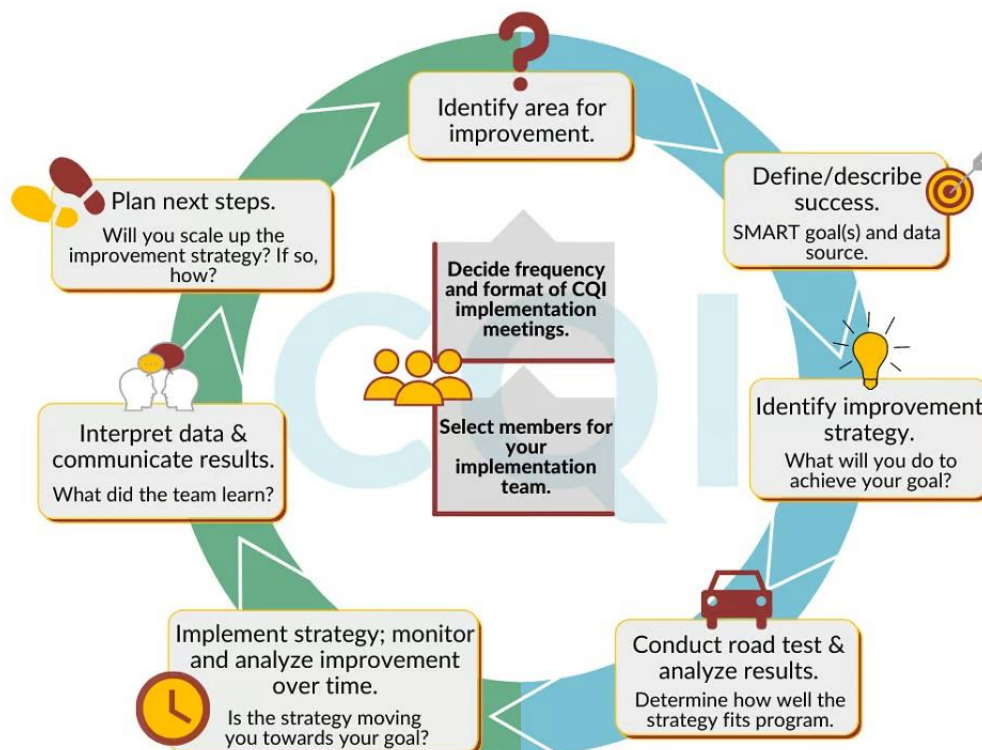
